a) to correct a typographical error in the price paid for the purchase of 75,000 shares from 90.60p to 90.00p.

All other details remain as previously announced. The full amended text as corrected is included below.

The Company announces that on 28 November 2023 it purchased 75,000 Ordinary shares of 1 penny each at an average price of 90.00 pence per share. The shares will be held in Treasury.

Following this transaction, the Company's issued ordinary share capital consists of 184,622,487 shares of which 3,210,863 shares are held in Treasury. Therefore, the total number of shares in circulation which hold voting rights in the Company is 181,411,624 Ordinary shares of 1 penny each. Each share has the right to one vote.

The above total voting rights figure may be used by shareholders as the denominator for the calculations by which they will determine whether they are required to notify their interest in the Company under the FCA's Disclosure Guidance and Transparency Rules.
